CONCEPT FIVE

THE RIGHTS OF APPEAL AND PETITION PROTECT MINORITIES AND INSURE THAT THEY BE HEARD.

"The Right of Appeal and Petition aim to protect and make the best possible use of minority feeling and opinion."

-Service Manual, page 190

When I first read this concept, I thought to myself, "I have a voice. I have a safe place to express my opinion." Where in the world outside 12-step programs does the minority get a voice? In Al-Anon, we want all of our members to be heard.

A huge program lesson for me has been learning to listen. Over the years, my listening skills at meetings have improved dramatically. Meetings are a safe place to discover how not to prejudge people.

When my sense of self-righteous indignation arises because I don't like how others are behaving, trouble for me quickly follows in the form of resentment and frustration. This concept reminds me that it's okay for a multitude of opinions/perspectives to exist. As human beings we are all in different places in our journeys. Each of us has our own path--that is just a fact of life. If we were all in the same place, how would we learn from each other's experience, strength and hope?

In April, when our Delegates are gathered together at conference, it is comforting to know that the Right of Appeal applies to Conference Members, Executive Committee, Trustees and WSO staff alike. Everyone is free to employ this concept to express their opinions—whether they be minority or majority. When decisions are being discussed and votes being made, we need to hear from all persons involved. Each individual brings their own experience, strength, and hope to the topics at hand.

Shifting to personal experience, Concept 5 has taught me to listen to my family members and friends. I can take my turn without dominating the conversion. At times, talking to people who do not work a 12-step program can be trying. They don't have the same communication tools I've been given. Here, sometimes I find it best to just listen and not say a word. I have a choice to "be right or be happy." I choose to be happy.

"When I get stuck in the box of my own thinking and can't get out, I am usually being petty or impatient. I may be hungry, angry, lonely, or tired. That's when I believe God speaks to me through the voice of someone expressing a minority opinion, regardless of what I think other people would prefer to hear."

Public Outreach Beacon

. . . Greetings to all from YOUR PO Team!



Recently a program friend shared she was relying on a certain type of transportation service (that begins with the letter "U") as she has been unable to drive her older model car due to its unreliability. This type of service was new to her and after learning how to use the car riding app, she reports she actually enjoys being picked up and taken to her appointments or the grocery store.

You may ask, what does this have to do with public outreach? Or how would someone share the program with a total stranger? It's best to preface this sto-

ry with the fact that this member is a very open and sharing individual. She can strike up a conversation with anyone.

My friend explained to me that she lives alone and enjoys conversing with the "U" drivers. She relates, "even though we start the ride as strangers I realize the drivers are people like me as they don't have a perfect life either. They deal with the same emotions I do such as loneliness, sadness, joy and fear." She feels it's important to pay close attention to the conversation and in doing so is able to share about how her life is better (to herself she thinks......it's the program work-ing)! If it feels appropriate, sometimes she gently weaves into the conversation a hint or two about Al-Anon. On a few occasions she has even shared the AIS office contact info and basic info about the Al-Anon program.

Be open to sharing the wonders of the program with someone! You may never know the effect your sharing will have on someone else. And remember, your sharing might just begin in the backseat of a "U" driver's car!



New Ideas for OUTREACH — Can you Help?

The Public Outreach committee is in the planning stages of their next outreach endeavor. Some members have suggested targeting hospital emergency rooms and walk-in medical clinics with Al-Anon literature. The hope is that employees of these various institutions would be able to share our information, as they deem appropriate, to patients and their families or visitors.

DISTRICT 2 HOLDS ALATEEN TRAINING WORKSHOP

Lisa G., Missouri Area Alateen Coordinator, presented a Training Workshop on March 25th to members in District 2 who have recently been certified as an Al-Anon Member in Alateen Service (AMIAS), who are pending certification and who may be interested in becoming an AMIAS. There were 9 members in attendance in addition to three Alateen Sponsors: Steve V., Cindy S. and Linda K. The sponsors shared their experiences as Alateen Sponsors and how important it is to be a recovery resource for teens who have an alcoholic family member or friend.

The workshop was especially helpful to members from Serenity Seekers who are planning to start a new Alateen group in Festus sometime in the next few months. Once details are firmed up and they are registered with WSO, members will focus on public outreach to the Jefferson County schools, churches and other locations. There are currently only three Alateen groups in the St. Louis Area but attendance is beginning to increase. Are You Being Called to Service?

WHAT IS THE AL-ANON AFG ST. LOUIS ANSWERING SERVICE?



These are the wonderful volunteers who respond to after hours calls made to the AIS Office. The Answering Service Coordinator coordinates the service and the volunteers talk to people

who have questions about Al-Anon, asking for meeting information, support, etc. Volunteers have a current Al-Anon Meeting Directory, or access to the St Louis Area website (**www.stl-alanon.org**) and Missouri Al-Anon website (**www.missouri-alanon.org**). These sites have the most up to date information. The Answering Service shifts are:

- Monday-Friday: 5:00-9:00pm
- Saturday: 9am-1pm, 1pm-5pm, 5pm-9pm
- Sunday: 9am-1pm, 1pm-5pm, 5pm-9pm

WHAT DUTIES ARE INVOLVED?

- The Coordinator ensures there are volunteers available to cover each shift.
- Trains new volunteers.
- Ensures there is holiday coverage when the office is closed.
- Is available if a volunteer may have a unique situation and needs to consult about how to handle it.
- Is the liaison with office staff to communicate about phone service issues or changes the volunteers need to be aware of (e.g., office hours change).
- Offers suggestions to the office for the daily or holiday greeting messages, as those messages apply to after hours availability.
- Provides a monthly accounting of the number of calls received, the nature of calls, and disposition by the volunteers who contacted the caller.
- Updates the volunteers regarding any changes or special requests.

This group of volunteers are all so loyal, long term and selfsufficient. Because we have pretty low activity there is not a lot of interaction. They are faithfully available to cover the shifts and when they do have activity, it is often a good 12- step call and an opportunity to pass on our message. While the numbers of calls have significantly dwindled I still feel the service is valuable. —Respectfully Submitted, Peggy B.

Some Thoughts on "Helping"

Al-Anon saved my life. I truly believe if I had not found this program, I would have died. Yet here I am, able to find happiness and joy, even though my life's circumstances aren't perfect. My program really came alive for me when I felt I had no choice but to kick my underage son out of the house. While it was one of the most painful things I had ever done, letting him stay in our home was even more painful. To help me get through the hard times, I would meditate on the following ideas.

It's happening to him; it's not happening to me. Oh, what a good empathizer I was. I would imagine my poor son—he must be so hungry and cold and lonely and sad and tired. I would become stricken with imagined grief, as if I were in his shoes. Yet, my son was out there living his life. In AI-Anon, I learned how to live my life fully and not project my wild imagination onto what he might be going through.

"Helping" him is not helping him. When I gave handouts to my son, it just prolonged his disease. I really just wanted to make myself feel better, and while I might feel some temporary relief, I would eventually come to regret my offers of assistance. Also, each time I rescued him, it gave him the message that someone would always take care of him. I had to learn to say no every single time he asked for something...

In Al-Anon, I've found many tools that I can rely on to help me get through challenging times. If I think I want to give something to the alcoholic or help him in some way, I will seek my Higher Power's wisdom before deciding. "The pessimist complains about the wind, the optimist waits for it to change. The realist adjusts the sail!"
